VOLUNTEER WAIVER OF LIABILITY - 2025 SEASON
SURFING FOR HOPE PURE STOKE CAMPS AND SURVIVOR CAMPS

This Waiver of Liability (the "Waiver") is executed online by me (the "Volunteer") in favor of Pismo Beach Surf Academy and any of their directors, officers, employees, agents, representatives, predecessors, and successors in interest (collectively, "Pismo Beach Surf Academy").

The Volunteer desires to work as a volunteer for Pismo Beach Surf Academy and engage in activities related to being a volunteer for the Surfing for Hope Pure Stoke Camp and Survivor Camp programs, including without limitation: surfing, swimming, lifting, physical labor, providing instruction, assistance, and transportation to and from the beach and/or business site (collectively, "Activities").

The Volunteer hereby freely and voluntarily executes this Waiver under the following terms:

1. Assumption of the Risk. The Volunteer understands that there are certain inherent risks and dangers associated with the Activities. By signing below, the Volunteer certifies that he or she is in reasonably good health and capable of engaging in the kind of physical Activities involved in the Surfing for Hope Pure Stoke Camp and Survivor Camp programs. Volunteer hereby expressly and knowingly assumes the risk of injury or harm resulting from participation in the Activities.
2. Release and Waiver. Volunteer does hereby release, forever discharge and hold harmless Pismo Beach Surf Academy, as well as any of its directors, officers, employees, agents, representatives, predecessors, successors and assigns from any and all liability, claims, and demands for negligence, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Surfing for Hope Pure Stoke Camp and Survivor Camp.
3. Medical Treatment. Volunteer does hereby release and forever discharge Pismo Beach Surf Academy from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Surfing for Hope Pure Stoke Camp and Survivor Camp.
4. Insurance. The Volunteer understands that Pismo Beach Surf Academy does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.
5. Photographic Release. Volunteer does hereby grant and convey unto Pismo Beach Surf Academy all right, title, and interest in any and all photographic images and video or audio recordings made by Surfing for Hope Pure Stoke Camp and Survivor Camp during the Volunteer's Activities.
6. Other. This Waiver shall be governed by and interpreted in accordance with the laws of the State of California.

Volunteer also agrees that in the event that any clause or provision of this Waiver shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect remaining provisions of this Waiver which shall continue to be enforceable.
